The undersigned, acting as the incorporator of a corporation organized under and pursuant to the provisions of Chapter 14A, 273, and 271B of the Kentucky Revised Statutes, states as follows:

**ARTICLE ONE**

The name of the corporation is Berea Youth Sports, Inc., and shall operate, as a non-profit, non-stock Corporation with the principal office address is 204 Laurel Drive, Berea, Kentucky 40403.

**ARTICLE TWO**

The duration of the corporation is perpetual.

**ARTICLE THREE**

The purpose or purposes for which this Corporation is organized is to operate as a non-profit charitable organization, in compliance with section 501(c)(3) of the Internal Revenue Code, organized exclusively for charitable, educational, social, or political purpose, and to solicit, receive, and manage contributions from individuals, businesses, and organizations made for the above purposes.

**ARTICLE FOUR**

The Corporation shall have no capital shares or shareholders, and its business and affairs shall not be conducted for private pecuniary gain or profit, nor shall any of the Corporation's gain profit or property inure to incorporators thereof, nor any officer or director thereof, but the Corporation's entire gain, profit, net earnings and property shall be devoted exclusively to the charitable and other uses and purposes set out in Article III of these Articles.

**ARTICLE FIVE**

The address of the initial registered office of Corporation is 204 Laurel Drive, Berea, Kentucky 40403, and the name of its initial registered agent at such address is Bernard Harris.

## ARTICLE SIX

The initial Board of Directors consisting of three (3) Directors who sha serve until the first annual meeting, or until their successors are elected and qualify, are as follows:

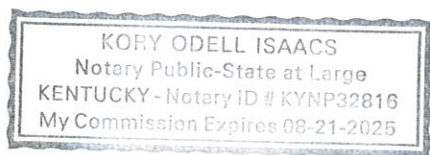
