

**ARTICLES OF ORGANIZATION
OF
EXPRESS ELECTRICAL SOLUTIONS, LLC**

SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS

The undersigned Organizer desires to form a limited liability company under the Laws of the Commonwealth of Kentucky by delivering these Articles of Organization in duplicate to the Secretary of State of the Commonwealth of Kentucky, in accordance with Kentucky Limited Liability Company Act (the *Act*).

SECTION 2 NAME

The name of the limited liability company is Express Electrical Solutions, LLC, a Kentucky limited liability company (*Company*).

SECTION 3 DURATION

The Company will perpetually exist from the filing date of these Articles of Organization with the Secretary of State of the Commonwealth of Kentucky, unless dissolved according to law.

SECTION 4 COMPANY'S PURPOSE

The Company's purpose is to engage in any lawful act or activity for which limited liability companies may be formed under the Act and all activities necessary or incidental to that purpose. The Company has all the powers necessary or convenient to carry out its purposes, including the powers granted by the Act.

SECTION 5 COMPANY'S PRINCIPAL OFFICE AND LOCATION OF RECORDS

The street address of the principal office in the United States where the Company maintains its records is 848 Ireland School Road, Radcliff, Kentucky 40160.

SECTION 6 REGISTERED AGENT AND REGISTERED OFFICE

The Company's initial Registered Agent is Jonathan Hosmon, and the Company's initial registered office is located at 848 Ireland School Road, Radcliff, Kentucky 40160.

SECTION 7 REGISTERED AGENT CONSENT

I, Jonathan Hosmon, a natural person and resident of Kentucky, accept the appointment as Registered Agent of Express Electrical Solutions, LLC, a Kentucky limited liability company. I understand that my responsibilities as Registered Agent are to receive service of process, notices, and demands; to forward mail; and to notify the Secretary of State immediately if I resign or if the registered office address changes from the addresses stated above.

This Operating Agreement may be amended from time to time according to its provisions.

SECTION 9 MANAGEMENT




