
Dear Mr. Reaves:

The Department of Revenue acknowledges receipt of the 501(c)(3) determination letter submitted in response to our request for evidence of your corporation's tax exempt status.

Therefore, based upon the information submitted, Southern Police Institute Alumni Association Inc is exempt from filing Kentucky Corporation Income and License Tax Returns pursuant to KRS 141.040 and KRS 136.070. This exemption does not apply to any other taxes administered by the Commonwealth of Kentucky.
