## ARTICLES OF MERGER OF MANAGEMENT-SSK, LLC A KENTUCKY LIMITED LIABILITY COMPANY WITH AND INTO

Pursuant to Sections 275.345 - 275.360 of the Kentucky Revised Statutes, and Title 6, Section 18-209 of the Kentucky Limited Liability Company Act, the undersigned adopt and execute these Articles of Merger:

**FIRST:** The business entities entering this merger are **MANAGEMENT-SSK**, **LLC**, a

Kentucky Limited Liability Company (sometimes referred to herein as the "Non-Surviving Company"), and **MHC MANAGEMENT, LLC**, a Kentucky Limited Liability Company (sometimes referred to herein as the "Surviving Company").

**SIXTH:** No changes are necessary to the current Articles of Organization of the Surviving

Company.

**SEVENTH:** A copy of the Plan of Merger is on file at 467 Erlanger Road, Erlanger, Kentucky

41018 and will be furnished by the Surviving Company on request, without cost,

to any member of Surviving Company or of the Non-Surviving Company.

**EIGHTH:** The Surviving Company agrees that it may be served with process in the

Commonwealth of Kentucky in any proceeding for enforcement of any obligation of the Non-Surviving Company, as well as for enforcement of any obligation of the Surviving Company. Unless and until Surviving Company appoints a registered agent in the Commonwealth of Kentucky, the Surviving Company appoints the Secretary of State of the Commonwealth of Kentucky as its agent for

service of process in any such proceeding. A copy of the process shall be mailed to the Surviving Company at 467 Erlanger Road, Erlanger, Kentucky 41018.

**NINTH:** The effective date of the Merger shall be the date of filing of these Articles of Merger with the Office of the Secretary of State of Kentucky.
