ARTICLE VIII

The corporation will accept charitable donations. In addition, the

The Corporation will not engage, other than as an insubstantial part of its activities, in activities that do not offer support and education for individuals impacted by Parkinson's Disease. No private pecuniary profit or gain shall be derived from its existence. The Corporation shall seek to qualify and maintain its existence under Section 501(c)(3) of the Internal Revenue Code as the same may be amended from time to time. The Corporation shall not engage in any activities that do not further its charitable mission or which would endanger the Corporation's tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE IX
