**ARTICLES OF INCORPORATION**  
**OF**  
**NAILS PRO 5 OF WINCHESTER, INC**

The undersigned incorporator executes these articles of incorporation for the purpose of forming and does hereby form a corporation under the laws of the Commonwealth of Kentucky in accordance with the following provisions:

**ARTICLE I**

The name of the corporation is: **NAILS PRO 5 OF WINCHESTER, INC.**

**ARTICLE II**

The duration of this corporation shall be perpetual.

**ARTICLE III**

The purpose and nature of the business which is to be transacted, promoted and carried on by this corporation is a property management and any and all other lawful businesses for which corporations may be incorporated under the Kentucky Revised Statutes.

**ARTICLE IV**

The private property of the shareholders shall not be subject to the payment of the corporate debts, liabilities or obligations to any extent whatsoever.

**ARTICLE V**

The street address of the initial registered office of the corporation in the Commonwealth of Kentucky is **1230 McClure Road, Winchester, Kentucky 40391**. The initial registered agent at the same address is Pokhon Kao. The mailing address of the principal office of the corporation is **1230 McClure Road, Winchester, Kentucky 40391**

**ARTICLE VI**

There shall be two (2) members of the initial board of directors, and thereafter the number shall be determined by the bylaws of the corporation.

The directors of the corporation shall not be personally liable to the corporation or its shareholders for the breach of his duties as a director except as allowed by Kentucky corporate law.

**ARTICLE VII**

The bylaws of the corporation may be amended or repealed only by action of the shareholders.

**ARTICLE VIII**

The total number of shares stock authorized to be issued shall be one thousand (1,000) shares of no-par value. The voting power of said stock shall be one vote per share. The stock shall consist of one class.






