

**ARTICLES OF INCORPORATION
OF

Comes the undersigned incorporator, Daniel Thompson, and hereby submits the following Articles of Incorporation in conformance with KRS 271B.2-020.

ARTICLE ONE

The name of the Corporation shall be: THOMPSON ENTERPRISES, INC.

The Corporation shall be authorized to issue 5,000 shares of common stock, which stock shall be without par value and divided into two classes, as follows:

1. Class A preferred stock, consisting of 5,000 shares;
2. Common stock, consisting of 5,000 shares.

The duration of this Corporation shall be perpetual.

ARTICLE FOUR

The purpose of this Corporation shall be the transaction of any and all lawful business for which corporations may be incorporated under the Kentucky Revised Statutes.

The business of the Corporation shall be managed by a Board of Directors, the number of which shall be from time to time established in the bylaws adopted by the shareholders of the Corporation.

ARTICLE NINE


A shareholder of the Corporation shall not be personally liable for the acts or debts of the Corporation except that he or she may become personally liable by reason of his or her own acts or conduct.
