

**Articles of Organization
of
Lake Cumberland Business Solutions, LLC**

KNOW ALL MEN BY THESE PRESENTS:

Comes now the undersigned, being a person of the age of twenty-one (21) years or more, desiring to form a Limited Liability Company, under the Laws of the Commonwealth of Kentucky, and hereby specify as follows:

ARTICLE I

The Company shall be known as Lake Cumberland Business Solutions, LLC, by which it may contract and be contracted with, sue and be sued, conduct its business and perform any and all other functions as authorized by law. TK Industries, LLC, shall be referred to in these Articles of Organization as the 'Company'.

ARTICLE II

The Company is organized with a general business purpose and has all powers provided by law and may use those powers for all lawful business for which companies may be organized, all to be in conformity with the Kentucky Revised Statutes and any and all applicable law.

ARTICLE III

The Company shall have all the powers conferred upon a company organized under the provisions of KRS 275 of the Kentucky Revised Statutes, and shall have all powers necessary, proper, convenient or desirable in order to fulfill and further the purpose of the Company.

ARTICLE IV

The members have promised to make contributions of cash and/or property in amounts at times described in the operating agreement. Initially, the members have contributed \$100.00 cash to the Company.

ARTICLE V

Unless dissolved earlier, the Company will dissolve automatically on December 31, 2060, or except for prior amendment to this Article, or by act of the Company or its members to avoid the dissolution upon said date.

ARTICLE VIII

The Company may admit new members as provided in the Company's operating agreement.

ARTICLE IX

The Company shall be managed by its members or by a committee composed of members, as further provided in the Company's operating agreement.

ARTICLE X

The Company shall, to the fullest extent permitted by and in accordance with the Kentucky Revised Statutes, indemnify each director, member, employee or agent of the Company if that person is made a party to any proceeding by reason of their relationship with the Company and that person conducted themselves in good faith, reasonably believed (while acting in their official capacity) their conduct was in the best interest of the Company and reasonably believed (while acting outside of their official capacity) their conduct was not opposed to the best interest of the Company, and in the context of a criminal proceeding they had no reasonable cause to believe their conduct was unlawful.

The Company shall indemnify a person against judgments, penalties, fines, settlements and reasonable expenses actually incurred by the person in connection with the proceeding, except that if the proceeding was by or in the

right of the Company, indemnification shall be made only against such reasonable expenses and shall not be made in respect of any proceeding in which the person has been adjudged liable to the Company. The termination of any proceeding by judgment, order, settlement, conviction or upon a plea of nolo contendere or its equivalent, shall not, of itself, be determinative that the person did not meet the requisite standard of conduct set forth in this Article.

The Company shall not be empowered to indemnify a person for any proceeding charging improper personal benefit to them, whether or not involving their action in their official capacity, in which they have been adjudged liable to the basis that personal benefit was improperly received by them.

The Company shall indemnify a person who has been wholly successful on the merits or otherwise, in the defense of any proceeding referred to in this Article.

The Company may indemnify and advance expenses to a person to such an extent consistent with the Kentucky Revised Statutes, these Articles of Organization, and the Company's Operating Agreement.

The Company may purchase and maintain insurance on behalf of any person who is or was a member, officer, employee or agent of the Company, or is or was serving at the request of the Company as a officer, partner, employee or agent of another domestic or foreign company or corporation, partnership, joint venture, trust, or other enterprise, against any liability asserted against them and incurred by them in such capacity or arising out of their status as such, whether or not the Company would have the power or be obligated to indemnify them against such liability under the provisions of this Article or the Kentucky Revised Statutes.

ARTICLE XI

The Operating Agreement for the government and operation of the Company may be adopted, amended, and repealed by the Members of the Company.

ARTICLE XII

The place in Kentucky where the initial registered office of the Company is to be located is 106 Walnut Drive, Burnside, Kentucky 42519, with such office to be deemed the principal place of business of such Company within the

Commonwealth of Kentucky; and the name and address of the initial registered agent for service of process is:


ARTICLE XIII

These articles of organization are executed in triplicate original, each having the full force and effect of an original.






