ARTICLES OF DISSOLUTION**

**NAME**

**EVENT OF DISSOLUTION**

KRS 275.315 requires the articles of dissolution to set forth a statement of the subsection of KRS 275.285 pursuant to which the limited liability company has dissolved.

**DISSOLUTION DATE**

Articles of dissolution shall be filed *after* the dissolution of the limited liability company. The date of dissolution is when the event of dissolution occurred. A dissolution date that is in the future will not be accepted for filing.

**ADDITIONAL INFORMATION**
