


**ARTICLES OF ORGANIZATION**  
**OF**

The undersigned, serving as organizer, hereby forms a Kentucky professional limited liability company (the "Company") pursuant to the Kentucky Limited Liability Company Act (the "Act"), KRS Chapter 275, as follows:


1. **Name**: The name of the professional limited liability company is Mangold Medical Services, PLLC.
2. **Initial Registered Office and Agent**: The street address of the professional limited liability company's initial registered office is 1531 London Drive, Murray, KY 42071. The name of its initial registered agent at that office is Melissa C. Mangold.
3. **Initial Principal Office**: The mailing address of the initial principal office of the professional limited liability company is 1531 London Drive, Murray, KY 42071.
4. **Statement of Management**: The professional limited liability company is to be managed by one or more managers, to be exercised in accordance with the operating agreement of the professional limited liability company.
5. **Profession**: The profession to be practiced by the professional limited liability company is the practice of medicine.
6. **Dissolution**: The Company does not have a specific date of dissolution. The Company shall dissolve as provided in the Act and the professional limited liability company's operating agreement.
7. **Statement of Limited Liability**: Except as otherwise provided by Kentucky law, no member, manager, agent or employee of the professional limited liability company shall be personally liable for the debts, obligations, or liabilities of the professional limited liability company, whether arising in contract, tort or otherwise, or for the acts or omissions of any other member, manager, agent or employee of the professional limited liability company.
