For the purposes of forming a limited liability company in Kentucky pursuant to Kentucky Revised Statutes Chapter 275, the undersigned organizer hereby submits the following Articles of Organization to the Office of the Secretary of State for filing:

Article I

The name of the company shall be J & D Mini Farm, LLC (hereinafter "the Limited Liability Company").

Article II

The street address of the Limited Liability Company's initial registered office in Kentucky is 163 Chambers Cemetery Road Danville, Kentucky 40422.

Article III

The mailing address of the Limited Liability Company's initial principal office is 163 Chambers Cemetery Road Danville, Kentucky 40422. The name of the initial registered agent at that office is Jimmy D. Gibson.

Article IV

The Limited Liability Company has at least two (2) Members. Members may be added or removed at the discretion of the pre-existing Members by a majority vote amongst the Members. A majority vote shall be at least a preponderance of the vote. A voluntarily withdrawing Member shall be compensated for his or her stake in the Limited Liability Company on a pro rata basis, assuming the withdrawal does not reduce the total membership to less than two (2) Members. The withdrawing Member's proportional stake is to be determined at the discretion of the Members.

Article V

The Limited Liability Company is to be managed by its Members.

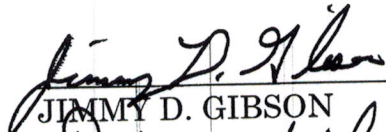
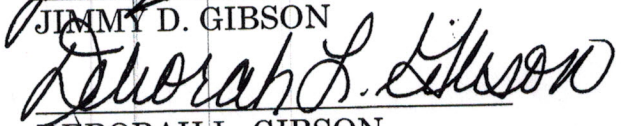
Article VI

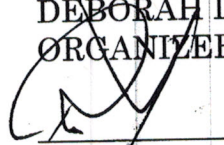
Any income or losses may be allocated amongst the several Members at the Members' discretion, in accordance with all municipal, state, federal, administrative, or other applicable law.
