

**ARTICLES OF INCORPORATION
OF
SHOCKING ELECTRIC, INC.**

We, the undersigned incorporators, having capacity to contract and acting as the incorporators of a corporation under the Kentucky Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

The corporation shall be named and known as Shocking Electric, Inc., by which name it may contract and be contracted with, sue and be sued, and do all things necessary or convenient to effect the purposes for which the corporation is organized.

ARTICLE II

The duration of the corporation shall be perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are: to provide commercial and residential electrical services; to engage in any or all lawful business for which corporations may be incorporated under the Kentucky Business Corporation Act; and to transact any or all lawful business for which corporations may be incorporated under the Kentucky Business Corporation Act.

ARTICLE IV

The corporation shall be authorized to issue an aggregate of one hundred (100) shares, consisting of one class of common stock only. The designation of the class of authorized shares, the number of shares of the class, and the par value (if any) of the shares of this class are as follows:

Common	100	Shares are without par value

ARTICLE V

The restrictions, qualifications, limitations, and relative rights in respect to the transfer of the authorized shares of common stock are as follows:

1. Shares of capital stock in the corporation shall be transferable only upon the books of the corporation; and
2. The Bylaws of the corporation may provide that the corporation shall have a right of first refusal to purchase any shares of capital stock of the corporation which any holder may desire to sell.

ARTICLE VI

The shareholders shall have preemptive rights to acquire unissued shares of capital stock to the fullest extent allowed by the Kentucky Business Corporation Act.

ARTICLE VII

The address of the initial registered office of the corporation is 7832 W KY 70, Liberty, Casey County, KY 42539, and the name of the initial registered agent for service of process at such address shall be Roger Dean Terry, Jr.

ARTICLE VIII

The address of the initial principal office of the corporation is 7832 W KY 70, Liberty, Casey County, KY 42539.

ARTICLE IX

The number of directors constituting the initial Board of Directors of the corporation is two (2), and the names and addresses of the persons who are to serve as the directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:



