The undersigned hereby amends the Articles of Organization for the limited liability company pursuant to the Kentucky Limited Liability Company Act and adopts the following Amended Articles of Organization of such limited liability company:

Certification

The current Article IV of the Limited Liability Company's Articles of Incorporation is hereby amended and replaced with the following new Article IV.

ARTICLE I

The name of the limited liability company is B&R Livestock, LLC.

ARTICLE II

ARTICLE III

ARTICLE IV

The limited liability company is amended to one (1) member, namely Troy Bradley Oliver.

ARTICLE V

The management of the limited liability company is reserved to the member, to be exercised in accordance with the Operating Agreement of the limited liability company.

ARTICLE VI

The duration of the limited liability company shall be perpetual, save and until its dissolution in accordance with the Kentucky Limited Liability Company Act and the Operating Agreement of the limited liability company.

ARTICLE VII

Except as otherwise provided by Kentucky law, no member, manager, agent or employee of the limited liability company shall be personally liable for the debts, obligations, or liabilities of the limited liability company, whether arising in contract, tort or otherwise, or for the acts of omissions of any other member, manager, agent or employee of the limited liability company.
