ARTICLES OF ORGANIZATION

- 1. <u>Name</u>: The name of the Company is Spring Creek Oaks Estates Property Owners Association, LLC.
- 2. <u>Initial Registered Office and Agent</u>: The street address of the Company's initial registered office is 1533 Spring Creek Drive, Murray, KY 42071. The name of its initial registered agent at that office is Howard Steely.
- 3. <u>Initial Principal Office</u>: The mailing address of the initial principal office of the Company is 1533 Spring Creek Drive, Murray, KY 42071.
- 4. <u>Statement of Management</u>: The Company is to be managed by one or more managers, to be exercised in accordance with the operating agreement of the Company.
