**ARTICLES OF ORGANIZATION**  
**FOR**  
**CONSTITUTIONAL FIREARMS, LLC**

The undersigned hereby forms and organizes a limited liability company, pursuant to the Kentucky Limited Liability Company Act, KRS 275.001, *et seq.*, and adopt the following as the Articles of Organization for the limited liability company:

**ARTICLE I**

The name of the limited liability company is Constitutional Firearms, LLC.

**ARTICLE II**

The street address of the limited liability company's initial registered office is 2410-B Fort Campbell Boulevard, Hopkinsville, Kentucky 42240, and the name of its initial registered agent at that office is John M. Dixon III.

**ARTICLE III**

**ARTICLE IV**

The limited liability company shall be managed by its member.

The limited liability company shall continue until dissolved in accordance with the Kentucky Limited Liability Company Act and the operating agreement of the limited liability company.


## **ARTICLE VI**

The status of a person as a member, manager, employee, or agent of the limited liability company shall not subject the person to personal liability for the acts or omissions, including any negligence, wrongful act, or actionable misconduct, of any other member, manager, employee, or agent of the limited liability company.

## **ARTICLE VII**




