## **ARTICLES OF ORGANIZATION**


#### ARTICLE VII

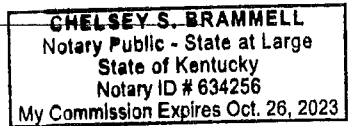
