

**ARTICLES OF INCORPORATION**  
**Nonprofit Corporation**  
**OF**

**LIFECHURCH146, Inc.**

The undersigned incorporators execute these articles of incorporation for the purpose of forming and do hereby form a nonprofit corporation under the laws of the Commonwealth of Kentucky, KRS 273.161 et seq., in accordance with the following provisions.

**ARTICLE I**

**Name**

The name of the corporation is lifeChurch146.

**ARTICLE II**

**Purpose and Powers**

(A) The corporation is organized and operated exclusively for religious and charitable purposes. In carrying out its corporate purposes, the corporation shall have all the powers allowed corporations by Chapter 273 of the Kentucky Revised Statutes.

(B) In furtherance of the general purposes in paragraph (A), the particular purposes of the corporation are: to promote and foster the tenets of the Christian faith, to develop a spirit of brother and sisterhood in worship and community service, to nurture a close relationship among the fellowship of worshipers at lifeChurch146, and to acquire and hold title to real and personal property for the use and benefit of the worshipers at lifeChurch146, and for such other purposes as may be consistent with the non-profit corporation and charitable corporation law of Kentucky.

**ARTICLE III**

**Directors**

The business and affairs of the corporation shall be governed by a board of directors. A director may be removed from office by vote of the worshipers in accordance with the bylaws, with or without cause. The name(s) and mailing addresses of the incorporating board of directors are as follows:





