# PRINCIPAL OFFICE ADDRESS

The principal office is the office (in or out of this state) so designated in writing with the Office of the Secretary of State where the principal designated office of the business entity is located. This address is where all correspondence from the Office of the Secretary of State (See Document Delivery) will be mailed.

# EFFECTIVE DATE AND TIME

The document will be effective on the date and time of filing.

# WHO MAY SIGN

The document must be signed by a member, manager or authorized party.
