

ARTICLES OF ORGANIZATION
OF
WEST KENTUCKY TURFPRO, LLC

The undersigned hereby forms and organizes a limited liability company pursuant to the Kentucky Limited Liability Company Act and adopts the following Articles of Organization of such limited liability company:

ARTICLE I

The name of this limited liability company is West Kentucky Turfpro, LLC (hereinafter, the "Company"). The purpose of the Company shall be to engage in the business of lawn maintenance and all purposes related thereto and to engage in any other lawful purpose.

ARTICLE II

The effective date of these Articles of Organization shall be the date these Articles are filed with the Kentucky Secretary of State.

ARTICLE III

ARTICLE IV

ARTICLE V

The Company shall be member-managed. The initial members of the Company will be Jordon Thomas Sullivan and Christa Lee Sullivan.

ARTICLE VI

The duration of the limited liability company shall be perpetual, save and until its dissolution in accordance with the Kentucky Limited Liability Company Act or the operating agreement of the Company.

ARTICLE VII

Except as otherwise provided by Kentucky law, no member, manager, agent, or employee of the Company shall be personally liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent, or employee of the Company.

ARTICLE VIII

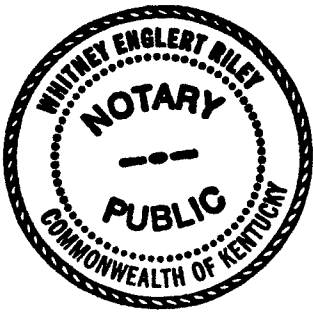
