DURATION**

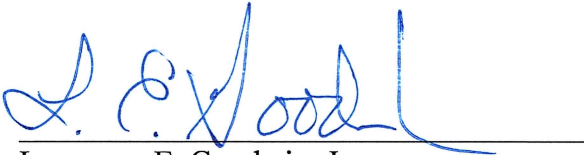
The duration of the Company shall be perpetual, save and until its dissolution in accord with the Kentucky Limited Liability Company Act and the operating agreement of the Company.

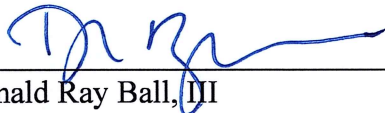
**CONSENT TO SERVE AS INITIAL REGISTERED AGENT**

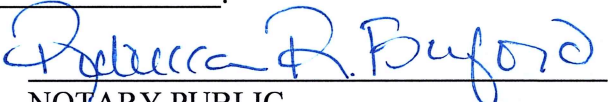
