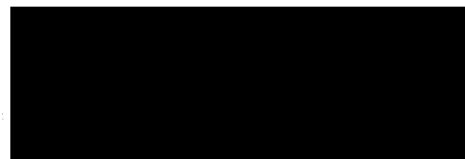

Re: Request for a Letter of Good Standing

Based upon the Department of Revenue records and the information submitted, **CHIMNEY ROCK NEIGHBORHOOD ASSOCIATION, INC.** is exempt from filing a Kentucky Corporation Income Tax Return pursuant to KRS 141.040, KRS 141.0401 and KRS 136.070.
