

ARTICLES OF ORGANIZATION

In order to form a limited liability company under Chapter 275 of the Kentucky Revised Statutes, the undersigned adopts these Articles of Organization and delivers these Articles of Organization to the Secretary of State of Kentucky for filing in accordance with KRS 275.020.

ARTICLE I

PURPOSE AND POWERS


