Pursuant to the provisions of KRS 14A and KRS Chapter 273, the undersigned applies to amend articles and, for that purpose, submits the following statements:

1. The name of the corporation on record with the Office of the Secretary of State is:

Red House Baptist Church, Inc.

(The name must be identical to the name on record with the Secretary of State.)

2. The text of each amendment adopted: Article X: Any action to dissolve Red House Baptist Church, Inc. must be approved by a two-thirds

vote with a quorum present at a duly called business meeting. Should said action be taken, the church's assets shall be distributed to Tates Creek

Baptist Association, provided it qualifies at such time for exemption as an organization described in Section 501(c)(3) of the Internal Revenue Code. In

the event that Tates Creek Baptist Association does not qualify or is no longer in existence, the assets of Red House Baptist Church shall be distributed

to another church or religious organization whose faith aligns with Red House Baptist's Statement of Faith, as approved by a two-thirds vote with a quorum present at a duly called business meeting.

3. The date of adoption of each amendment was July 27, 2023

4. Check either a, b or c (whichever is applicable):

a. The amendment(s) was (were) duly adopted by a quorum present at such meeting and that such amendment received at least two-thirds (2/3) of the votes which members present at such meeting or represented by proxy were entitled to cast.

b. The amendment(s) was (were) duly adopted by consent in writing and was (were) signed by all members entitled to vote with respect thereto.

c. The amendment(s) was (were) duly adopted by the board of directors and such amendment(s) received the vote of a majority of the directors in office since there are no members or members entitled to vote.

5. This application will be effective upon filing.
