

ARTICLES OF ORGANIZATION
OF
VANDEVER INVESTMENTS, LLC

KNOW ALL MEN BY THESE PRESENTS that the undersigned hereby proposes to form a limited liability company pursuant to the Kentucky Limited Liability Company Act, Chapter 275 of the Kentucky Revised Statutes and files therefore the following Articles of Organization:

ARTICLE I

The name of the company shall be Vandever Investments, LLC (hereinafter "the company").

ARTICLE II

The street address of the company's registered office and the name of its initial registered agent at that office are Vincent F. Heuser, Jr., 3600 Goldsmith Lane, Louisville, KY 40220.

ARTICLE III

The mailing address of the company's principal office is 806 Twelve Oaks Dr., Mt. Washington, KY 40047.

ARTICLE IV

The company is to be managed by its members. The initial members are Jeremy G. Vandever and Amy E. Vandever.

ARTICLE VI

The duration of the company is perpetual.

ARTICLE V

To the fullest extent permitted by law, the company shall indemnify each member, manager or officer of the company against expenses (including attorneys' fees), judgments, taxes, penalties,

finances (including any excise tax assessed with respect to an employee benefit plan) and amounts paid in settlement (collectively "Liability"), incurred by such member, manager or officer in connection with defending any threatened, pending, or completed action, suit, or proceeding (whether civil, criminal, administrative, or investigative) to which such member, manager or officer is, or is threatened to be made, a party because such member, manager or officer is or was a member, manager or officer of the company. The indemnification against Liability and advancement of expenses granted pursuant to this Article shall not be deemed exclusive of any other rights to which those seeking indemnification or advancement may be entitled. The company may purchase and maintain insurance on behalf of an individual who is or was a member, manager, officer, employee or agent of the company.

ARTICLE VI

To the fullest extent permitted by law a manager or officer of the company shall not be personally liable to the company or its members for monetary damages for breach of the manager or officer's duties as a manager or officer.


ARTICLE VII

ARTICLE III


