ARTICLES OF ORGANIZATION

OF

VANDEVER INVESTMENTS, LLC

KNOW ALL MEN BY THESE PRESENTS that the undersigned hereby proposes to form a limited liability company pursuant to the Kentucky Limited Liability Company Act, Chapter 275 of the Kentucky Revised Statutes and files therefore the following Articles of Organization:

ARTICLE I

The company may purchase and maintain insurance on behalf of an individual who is or was a member, manager, officer, employee or agent of the company.

ARTICLE VI

To the fullest extent permitted by law a manager or officer of the company shall not be personally liable to the company or its members for monetary damages for breach of the manager or officer's duties as a manager or officer.

ARTICLE VII

The purposes for which the company is organized include the transaction of all lawful business in which Kentucky limited liability companies are permitted to be engaged and specifically to invest in and hold real and personal property.
