# ARTICLES OF INCORPORATION OF UFKAIP INC.

#### A Kentucky Non-profit Corporation

Pursuant to K.R.S. 14A and K.R.S. 273, the undersigned incorporator applies to qualify and for that purpose submits the following statements:

#### Article I. Name.

The name of the corporation is UFKAIP Inc.

#### Article 2. Purpose.

The purpose of the corporation is to be a "political organization" as defined at Section 527(e)(1) of the Internal Revenue Code of 1986 ("IRC") or any successor provision of the IRC, and to conduct activities that are for an "exempt function" within the meaning of Section 527(e)(2) of the IRC, and to otherwise engage in activities not prohibited for an organization exempt from taxation under Section 527 of the IRS.

The corporation is not organized for profit, shall not issue any shares, and no part of the net earnings of the corporation shall inure to the benefit of any member of the Board of Directors or any other individual except that the corporation may make payments of reasonable compensation for services rendered.

Notwithstanding any provision of these Articles of Incorporation, the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 527 of the IRC.

#### **Article 3. Registered Agent and Registered Office.**
