ARTICLES OF MERGER

SEVENTH: The merger shall become effective upon the filing of this Articles of Merger with the Secretary of State of the State of Kentucky.

EIGHTH: The merger is permitted by the jurisdiction of incorporation of KidVestors, Inc. and is in compliance therewith.
