**AMENDED and RESTATED ARTICLES OF INCORPORATION  
OF**

**SPEEDY CASH CHECK ADVANCE, INC.**

**KNOW ALL MEN BY THESE PRESENTS:**

That we, the undersigned, do hereby restate, declare and affirm the intent and purpose to continue business as a corporation under the laws of the Commonwealth of Kentucky.

**ARTICLE I**

The name of the Corporation shall continue to be Speedy Cash Check Advance, Inc., and its principal office shall be located at 308 Dorton Street, P.O. Box 46, Dorton, Kentucky, 41520.

**ARTICLE II**

The purpose and nature of business to be transacted, promoted and carried on shall be the ownership and operation of check cashing locations, and any and all other business purposes for which corporations may be formed under the laws of the Commonwealth of Kentucky; and to have and exercise all powers enumerated in Kentucky Revised Statutes Chapter 271B, Subtitle 3, and any and all other powers not forbidden by law, necessary and incidental to such businesses.

### **ARTICLE III**

The total number of shares the corporation shall have authority to issue is One Hundred (100) shares, no par value, all of which are to be designated common shares. The voting power of such stock shall be one vote per share.

### **ARTICLE IV**

If, at any time, a shareholder decides to sell his/her stock, the corporation, and/or other shareholders of the corporation, shall have the right of first refusal to repurchase the stock for the fair market value of the stock. The fair market value of the stock shall be determined by an appraisal of the corporation's net worth at the time of the repurchase.

## **ARTICLE IX**

The private property of the shareholders shall not be subject to the payment of the debts and liabilities of the corporation.
