# ARTICLES OF INCORPORATION OF

## SACRAMENTO ELEMENTARY PARENT TEACHER ORGANIZATION, INC

The undersigned incorporators execute these articles of incorporation for the purpose of forming and do hereby form a nonprofit corporation under the laws of the Commonwealth of Kentucky, KRS 273.161 et seq, in accordance with the following provisions.

**ARTICLE I** 

## NAME

The name of the corporation is Sacramento Elementary Parent Teacher Organization, Inc.

**ARTICLE II** 

### **PURPOSES AND POWERS**

- (A) The corporation is organized and operated exclusively for educational purposes. In carrying out its corporate purposes, the corporation shall have all the powers allowed corporations by Chapter 273 of the Kentucky Revised Statutes.
- (B) In furtherance of the general purposes in paragraph (A), the particular purposes of the corporation are: To conduct fund-raising events and use the funds raised to support the students and teachers of Marie Gatton Phillips Elementary School, AKA Sacramento Elementary School.

**ARTICLE III** 

#### **DIRECTORS**

The business and affairs of the corporation shall be governed by a board of directors.
