Articles of Dissolution

NPD

Pursuant to the provisions of KRS 14A and KRS 273.313, the undersigned corporation executes the following articles of dissolution:

Article I: The name of the non-profit corporation is **RUSSELL COUNTY SOCCER BOOSTER CLUB, INC.**

Article II: The date the dissolution was authorized: **8/20/2023**

Article III: This dissolution was approved by **the members.**

Article IV: The voting information is listed below.

Number of votes entitled to be cast on proposal to dissolve	10
Number of votes cast for the dissolution	9
Number of votes cast against the dissolution	1
The number cast for dissolution was sufficient for approval	

Article V: The assets of the corporation shall be distributed pursuant to the following plan of distribution:

(a) All liabilities and obligations of the corporation shall be paid and discharged, or adequate provisions shall be made therefor;

(b) Assets held by the corporation upon condition requiring return, transfer or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred or conveyed in accordance with such requirements;

(c) Assets received and held by the corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational or similar purposes, but not held upon a condition requiring return, transfer or conveyance by reason of the dissolution, shall be transferred or conveyed to **\$5,687.01 and all boys uniforms will be transferred to Russell County Boys Soccer, Inc. which is a nonprofit soccer league.**

\$9,887.02 Will be transferred to Russell County Futbol Club, Inc. which is a nonprofit soccer league.

Russell County High School, two 8x24 game goals, two 8x24 practice goals, four small practice goals, two indoor soccer goals, game balls, practice balls, one field striper, one popcorn popper, one hot dog roller, one crockpot, one coffee maker, one gimbal sport recorder and tripod, 8 point sport cool drink station, girls soccer uniforms, corner flags, two water coolers.;

(d) Other assets, if any, shall be distributed in accordance with the provisions of the articles of incorporation or the bylaws to the extent that the articles of incorporation or bylaws determine the distributive rights of members, or any class or classes of members, or provide for distribution to others;

(e) Any remaining assets may be distributed to **Russell County Futbol Club, Inc..**
