

ARTICLES OF ORGANIZATION

The undersigned, serving as the organizers, hereby form a Kentucky limited liability company pursuant to the Kentucky Limited Liability Company Act (the "ACT"), KRS Chapter 275, as follows:

ARTICLE I
NAME

STATEMENT OF MEMBERS


The Company has at least two (2) members.

DISSOLUTION





STATEMENT OF CONSENT OF INITIAL REGISTERED AGENT


