## **Declaration of Mission of the House of Dinkins and Articles of Unincorporation**

This Declaration of Mission of the House of Dinkins shall operate as evidence of the private Articles of Unincorporation styled as **House of Dinkins**, stated this 10<sup>th</sup> day of May 2023 as such. These articles act to establish the Chapel of the House of Dinkins by the Word of the Elohim (Jeremiah 29:4-7) and shall extend to any ministry activities and outreach performed under the Spiritual mission of Michael Edward Dinkins as its Chaplain. The mission of the House of Dinkins shall be guided by the Word of the Creator, (John 1:1) *“In the beginning was the Word, and the Word was with God, and the Word was God.”* The Word has established the House of Dinkins in Jeremiah 29:5: *“Build ye houses, and dwell in them; and plant gardens, and eat the fruit of them”* Of this promise I hold fast and true in the establishment of the House of Dinkins in the Kingdom of God on Earth...*Thy Will be done, on earth as it is in Heaven.*

### **The Mission**

The primary mission of the Unincorporated Association is to connect all living souls to the One True Creator, Elohim, so that they can fulfill and express their divine potential and mission and do the same for others (Matthew 5:16 and 28:19-20) (Luke 10:27) (Galatians 6:2). This will be accomplished utilizing religious, spiritual, educational, and scientific technology so that they may be free to express their spiritual beliefs and knowledge. We will insulate and protect the true nature of man (Genesis 2:7), and their physical sanctuary (1 Corinthians 3:16), from man-made rules or dominion by opposing elemental spiritual forces (Galatians 4). This declaration is an act of free exercise of spiritual beliefs of the ministers of the House of Dinkins in accord with existing laws relative to the immunities and protections for said acts and deeds in pursuit of infinite life, liberty, and happiness, while executing the general terms of the Will of the One True Creator, Elohim, the Ministry of Reconciliation, and laws of the Most High El Elohim which are written in the heart of the living soul. The House of Dinkins shall endeavor to care for his brethren, and to promote life, perfect mental, physical, and spiritual health, to foster peace through neutrality, avoid conflict, and spread spiritual ministry with adherence to the laws of the One True Creator, Elohim, and shall not be drawn into conflict with the earthly High Contracting Parties, presumptively or otherwise (Romans 12).

### **Purpose, Formation, and Mandatory Exclusions**

This *private* Unincorporated Association is formed under the laws of the Kingdom of the One True Creator, Elohim, and shall evidence an entity, not formed under or subject to the laws of the United States, any state, or a third party country, and shall be recognized as a *foreign state*, and a *private* international organization, with express immunity set forth in the existing laws and treaties in force in the Kingdom of God on Earth.

This private association falls under the mandatory exclusions and exceptions from all civil (“Roman”) taxation (1 Esdras 8:22) and filing requirements by taxing authorities and its sanctuary, physical temple/church, books, and records are inviolable by operation of law and international treaties in force.

## **Declaration of Mission of a Living Soul and Articles of Unincorporation Michael Edward Dinkins**

This Declaration of Mission of the living soul, Michael Edward, shall operate as evidence of the private Articles of Unincorporation styled as **Michael Edward Dinkins**, restated this 10<sup>th</sup> day of May 2023, and relates back to the date of origin of the embodiment of the living soul on 25 July 1966. These articles act as a counter-deed to the “incorporation” of the living soul and return the living soul named herein to the original jurisdiction of the One True Creator, Elohim.

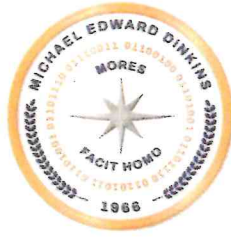

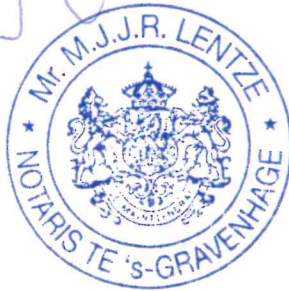
