# ARTICLES OF ORGANIZATION

The undersigned forms a Kentucky limited liability company pursuant to the Kentucky Limited Liability Company Act (the "<u>Act</u>"), KRS Chapter 275, hereby makes, acknowledges, and files the following Articles of Organization:

# **ARTICLE 1**

#### NAME

The name of the limited liability company is Hadley Continuum Property, LLC (the "Company").

## ARTICLE II INITIAL PRINCIPAL OFFICE

## ARTICLE VII STATEMENT OF LIMITED LIABILITY

Except as otherwise provided by Kentucky law, no member, manager, agent, or employee of the Company shall be personally liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent, or employee of the Company.

# ARTICLE VIII PURPOSE, RESTRICTIONS ON OPERATIONS

The Company is being organized for purposes of (i) engaging in any lawful acts or activities for which limited liability companies may be formed under the Act; and (ii) operating as a "qualified opportunity zone business" as defined in IRC Section 1400Z-2(d)(3). The Company intends to acquire and substantially improve "qualified opportunity zone business property" as defined in IRC Section 1400Z-2(d)(D) and use such property in the Company's business.
