ARTICLES OF INCORPORATION

We, the undersigned residents of the Commonwealth of Kentucky, being eighteen (18) years or more of age, do hereby execute this instrument for the purpose of forming a charitable, nonprofit corporation under the statutes of the Commonwealth of Kentucky:

ARTICLE I

The name of the corporation shall be the American Legion Auxiliary, Moon Brothers Unit 275, Inc. and its principal office shall be P.O. Box 36, Independence, KY 41051

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The business and purpose of this corporation shall be as be as follows:

Said organization is organized exclusively for charitable, religious, educational, and/or scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(19)of the Internal Revenue Code or corresponding section of any further Federal Tax Code.

No part of the next earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, directors or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the caring none of propaganda, or otherwise attempting to influence legislation and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carrying on any other activities not permitted to be carried (a) by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue code corresponding section of any future Federal Tax Code or (b) by an organization, contributions which are deducted under Section 170 (c)(.2) of the Internal Revenue Code or corresponding section of any future Federal Tax Code.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the organization is then located, exclusively for such purposes of to such organization a said court shall determine, which are organized and operated exclusively for such purposes.
