ARTICLES OF INCORPORATION OF GLOBESIL INC.

ARTICLE I

Name

The name of the Corporation is GlobeSil Inc.

ARTICLE II

Purposes

The purposes for which the Corporation is organized are to transact any and all lawful business for which corporations may be incorporated under the Kentucky Business Corporation Act (the "Act"), and exercise any and all powers that corporations may now or hereafter exercise under the Act.

ARTICLE III

Duration

The duration of the Corporation shall be perpetual.

<u>Shares</u>

The total number of shares which the Corporation is authorized to issue is 1,000 common shares, without par value. The number of directors shall consist of not less than one (1) person nor more than five (5) persons, the number to be set in the manner provided in the bylaws. The initial board of directors shall consist of three (3) persons, as follows, who shall serve until the first annual meeting of Shareholders or until his successor is elected and qualified.

The board of directors of the Corporation, to the extent not prohibited by law, shall have the power to cause the Corporation to repurchase its own shares and shall have the power to cause the Corporation to make distributions, from time to time, to the Corporation's shareholders.
