# ARTICLES OF INCORPORATION OF SHELBY COUNTY JUNIOR GOLF FOUNDATION INC. (A NONPROFIT CORPORATION)

For the purposes of forming a nonprofit corporation in Kentucky pursuant to KRS Chapter KRS 273, I the undersigned incorporator hereby submit the following Articles of Incorporation:

# **ARTICLE I**

The name of the Corporation shall be:

# Shelby County Junior Golf Foundation Inc.

#### **ARTICLE II**

The purpose for which the corporation is organized is as follows:

The purposes for which the corporation is organized are exclusively charitable, religious, literary and other not for profit activities within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, including all purposes and exercising all powers authorized by Kentucky Law.

Not withstanding any other provisions of these article, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of the Section 501(c)(3) of the Internal Revenue code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

#### ARTICLE III

# **ARTICLE IV**

#### ARTICLE V

The duration of the Corporation shall be perpetual or until sooner dissolved by appropriate action according to law.

#### **ARTICLE VI**

The corporation is organized and shall be operated exclusively for charitable and other not for profit purposes as described with in Section 501(c)(3) of the Internal Revenue Code (or corresponding provisions of any later Federal tax laws), including for such purposes as the making of distribution to organizations and individuals for the purpose of engaging in activity falling with the purposes of the Corporation and permitted for an organization exempt under said Section 501(c)(3).

#### **ARTICLE VII**
