7. Additional Liability of Members

That additional capital contributions will be required as needed as agreed to by the Members.

8. Admission of Additional Members

Additional Members will be admitted or expelled only with the unanimous consent of all Members entitled to participate in management and upon such terms as are unanimously agreed to by all Members entitled to a dividend upon dissolution or liquidation.

9. Continuity of Life
