

## **Articles of Organization**

The undersigned, Mark A. Walden, for the purpose of forming a limited liability company under the Kentucky Limited Liability Company Act, Kentucky Revised Statutes Chapter 275 (the "Act"), hereby makes, acknowledges and files the following Articles of Organization:

#### **Article I** **Name**

The name of the limited liability company is "Clean Cut, LLC" (the "Company").

#### **Article II** **Initial Principal Office**

The mailing address of the initial principal office of the Company in Kentucky shall be 501 Darby Creek Dr. Ste. 56A Lexington, KY 40509

#### **Article III** **Duration**

The Company shall commence its existence on the date of these articles of Organization are filed with the Kentucky Secretary of State. The Company's existence shall be perpetual, save and until its dissolution in accordance with the Act and the Company's Operating Agreement.

#### **Article IV** **Powers**

The Company shall have all the powers granted to a limited liability company under the laws of the Commonwealth of Kentucky.

#### **Article V** **Registered Office and Agent**

The street address of the Company's initial registered office in the Commonwealth of Kentucky is 501 Darby Creek Dr. Ste. 56A Lexington, KY 40509. The name of the initial registered agent of the Company at that office is Mark A. Walden.

The Company shall have one member: Mark A. Walden


**Article VII**

**Statement of Limited Liability**


