**ARTICLES OF ORGANIZATION  
OF  
RBT INSURANCE AGENCY LLC**

The undersigned forms a Kentucky limited liability company pursuant to the Kentucky Limited Liability Company Act (the “Act”), KRS Chapter 275, hereby makes, acknowledges, and files the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the limited liability company is RBT Insurance Agency LLC (the “Company”).

**ARTICLE II  
INITIAL PRINCIPAL OFFICE**

The mailing address of the initial principal office of the Company shall be: REPUBLIC CORPORATE CENTER, 601 W. Market Street Louisville, KY 40202.

**ARTICLE III  
DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed with the Kentucky Secretary of State. The Company’s existence shall be perpetual, save and until its dissolution in accordance with the Act and the company’s Operating Agreement.

**ARTICLE IV  
POWERS**

The Company shall have all the powers granted to a limited liability company under the laws of the Commonwealth of Kentucky.

**ARTICLE V  
REGISTERED OFFICE AND AGENT**

The street address of the Company’s initial registered office in the Commonwealth of Kentucky is: 601 W. Market St., Louisville, KY 40202. The name of the initial registered agent of the company at that office is: Christy A. Ames.

**ARTICLE VI  
MANAGEMENT**

The management of the Company is reserved to its members, to be exercised in accordance with the Company’s Operating Agreement. The Operating Agreement may contain any provisions

for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.

**ARTICLE VII  
STATEMENT OF LIMITED LIABILITY**

Except as otherwise provided by Kentucky law, no member, manager, agent, or employee of the Company shall be personally liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent, or employee of the Company.

**ARTICLE VIII  
PURPOSE, RESTRICTIONS ON OPERATIONS**

The Company is being organized for purposes of (i) providing insurances services and/or other insurance agency activities, as shall be determined by the Member from time-to-time, and (ii) engage in any other lawful acts or activities which are permissible under relevant law, including the Act, as may be determined by the Member.
