For the purposes of forming a non-profit corporation in Kentucky pursuant to KRS Chapter 273, the undersigned incorporator hereby submits the following Articles of Incorporation to the Office of the Secretary of State for filing:

Article I

The name of the Corporation is Knox Central High School Cross Country/Track & Field Boosters, Inc.

Article II

The duration of the Corporation is perpetual, or until dissolved or terminated in a manner prescribed by law.

Article III

The Corporation is organized and operated exclusively for educational and charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. Said corporation's purpose is to promote the activities of the Knox Central High School Cross Country/Track & Field organization, its athletes and coaches and to provide financial assistance for equipment, uniforms, tournaments, travel and any other need of the organization. The activities of the Corporation include, but are not limited to:

- Raise funds and purchase personal property and services to be used by Knox Central High School Cross Country/Track & Field;
- Provide volunteers for educational and/or extracurricular activities for Knox Central High School Cross Country/Track & Field;
- Engage in other charitable, civic, or educational activities that contribute to the promotion of Knox Central High School Cross Country/Track & Field; and
- Exercise other powers conferred by the laws of Kentucky on nonprofit corporations.

The corporation shall conduct any and all lawful activities that may or may not be

mentioned above, for the furtherance or accomplishment of the foregoing purposes, provided that such activities would not endanger the Corporation's not-for-profit status under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code.

Article IV

This organization shall not discriminate on the basis of political or religious affiliation, marital status, race, color, creed, national origin, gender, age or disability of individuals.

Notwithstanding any other provision of these articles, the corporation/organization shall not carry on any other activities not permitted to be carried on (a) by a corporation/organization exempt from Federal income tax under Section 501(c)(3) of the Internal Code (or corresponding section of any future federal tax code) or (b) by a corporation/organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

No part of the net earnings of the corporation/organization shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of Section 501(c) (3) purposes set forth in Articles hereof.

No substantial part of the activities of the corporation/organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Article V

In the event of dissolution of this corporation/organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.
