

**ARTICLES OF ORGANIZATION
OF
LAMPLIGHT CAFE, LLC**

The undersigned hereby organizes a Kentucky Limited Liability Company pursuant to the Kentucky Limited Liability Company Act (the "Act") and adopts the following Articles of Organization of such limited liability company:

ARTICLE I

NAME OF LIMITED LIABILITY COMPANY

The name of the limited liability is Lamplight Cafe, LLC (the "Company").

ARTICLE II

INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT

The street address of the Company's initial register office is 800 Dodson Lane, Madisonville, Hopkins County, Kentucky 42431. The name of the Company's initial registered agent as such office is David L. Webb.

ARTICLE III

INITIAL PRINCIPAL OFFICE

ARTICLE IV

PURPOSE OF COMPANY

The purpose for which the Company is organized is to engage in all business allowed under the laws of the Commonwealth of Kentucky and any lawful acts or activities for which limited liability companies may be organized under the Act.

ARTICLE V

MEMBERS

The Company has one or more members.

ARTICLE VI

MANAGEMENT

The Company's management is reserved to its members.

ARTICLE VII

DURATION OF COMPANY

Unless earlier dissolved in accordance with the Act and the Company's operating agreement, the Company shall have a perpetual duration from the effective date of the Company's Articles of Organization.

ARTICLE VIII

LIMITATION OF LIABILITY

Except otherwise provided by Kentucky law, no member, manager, agent or employee of the Company shall be liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent, or employee of the Company.
