RE: Use of Corporate Names "Peak Trust Financial Companies, Inc." and "Peak Trust Financial Group, Inc."

Dear Mr. Powell:

This letter is in response to your letter dated July 17, 2019, and subsequent correspondence regarding the proposed use of the captioned corporate names. According to your request, the captioned entities are a licensed insurance agency that sells insurance and annuity products and a licensed investment advisory that provides wealth managed management services, both in Texas and several other states.

Generally, we will grant a request for a letter of no objection for use of a term identified in Sections 31.005 and 181.004(a) of the Texas Finance Code (the "Code") if in context the term is not otherwise misleading and is used as a term of art in a manner and context that clearly invokes an established secondary meaning. We have reviewed your requests and determined that the names as proposed do not appear to be prohibited by Sections 31.005 and 181.004(a) of the Code. Therefore, we do not object to the use of the captioned corporate names.

The review of your requests are based upon the information you provided to this office taken as a whole, including commitments given in support of the request. If any of the facts of which you have informed us change in any material way, you should notify us immediately. Additionally, any variation now or in the future in the presentation, nature of financial services provided, or usage of a name (such as the use of part of the whole name requested) may be objectionable to this office. If such occurs, this office should be notified immediately; and, should it be determined by this office that the services provided, or the actual usage of a name is prohibited, appropriate steps will be taken to fully enforce the Code.

This expression of no objection does not obligate the Texas Secretary of State to approve such names. This determination does not authorize the use of such names contrary to any state or federal law.
