The undersigned citizen of the United States, desiring to form a Non-Profit Limited Liability Company (LLC) under the Non-Profit Limited Liability Law of Kentucky, do hereby certify:

First: The name of the LLC shall be Les Rainey.

Second: The place in this state where the principal office of the LLC is to be located is the City of

Louisville, Kentucky, Jefferson County.

Third: Said LLC is organized exclusively for charitable, religious, educational, and scientific

> purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the

corresponding section of any future federal tax code.

Fourth: The names and addresses of the persons who are the initial trustees of the LLC are as

Fifth: No part of the net earnings of the LLC shall inure to the benefit of, or be distributable to its

members, trustees, officers, or other private persons, except that the LLC shall be authorized and empowered to pay reasonable compensation for services rendered and to make

payments and distributions in furtherance of the purposes set forth in Article Third hereof. No

substantial part of the activities of the LLC shall be the carrying on of propaganda, or

otherwise attempting to influence legislation, and the LLC shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the LLC shall not carry on any other activities not permitted to be carried on (a) by a LLC exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a LLC, contributions to

which are deductible under section 170(c)(2) of the Internal Revenue Code, or the

corresponding section of any future federal tax code.

Sixth: Upon the dissolution of the LLC, assets shall be distributed for one or more exempt purposes

> within the meaning of section 501 (c)(3) of the internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of

the LLC is then located, exclusively for such purposes or to such organization or

organizations, as said Court shall determine, which are organized and operated exclusively

for such purposes.
