Pursuant to KRS 14A and KRS 273, the undersigned hereby forms a nonprofit corporation and for that purpose sets forth the following:

Article I: The name of the nonprofit corporation is

Article II: The purpose of the nonprofit corporation is **The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. The particular purpose of the corporation is to provide assistance to people following a natural disaster or severe weather event by removing trees and other debris from an impacted owner's property through the use of coordinated teams of volunteers. Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding sections of any future federal tax code, or shall be distributed to the Federal, state or local government for a public purpose.**
