# *ARTICLES OF INCORPORATION*

OF

## **NEHEMIAH'S WALL MINISTRY INC.**

### *KNOW ALL MEN BY THE PRESENTS:*

The undersigned, by these Articles of Incorporation, forms a non-profit corporation under the laws of the Commonwealth of Kentucky and hereby adopts the following Articles:

### ***ARTICLE I***

The name of this non-profit Corporation shall be named and known as: NEHEMIAH'S  
WALL MINISTRY INC.

### ***ARTICLE II***

The period of duration of NEHEMIAH'S WALL MINISTRY INC., is that of perpetual existence.

### ***ARTICLE III***

This Corporation is established to promote religious and spiritual growth, provide compassionate guidance and support, conduct sacred ceremonies, engage in charitable endeavors, and contribute to the betterment of individuals and communities. The Corporation shall also be empowered to undertake any lawful activities within the Commonwealth of Kentucky that align with its mission. It shall possess the authority to engage in acts necessary to fulfill its purpose, including collaboration, acquisition, and prudent financial management, all while adhering to the laws of the Commonwealth of Kentucky.

This Corporation's activities shall be guided by its dedication to its mission, and it shall have the full range of powers granted to corporations under the laws of the Commonwealth of Kentucky as well as any additional powers authorized by future legislation.

The Corporation shall be authorized to engage in all acts consistent with the purposes set forth in the Articles of Incorporation, as well as those now or hereafter authorized by law for corporations. It is expressly intended that the enumeration of specific powers contained herein shall not serve to limit, in any manner, the broad and general powers conferred upon corporations by the laws of the Commonwealth of Kentucky. The Corporation shall possess and exercise all rights, authority, and privileges bestowed upon corporations under the statutes of the Commonwealth of Kentucky.

## ***ARTICLE IV***

This Corporation reserves the right to ratify any and all acts of its Incorporator prior to the date of its incorporation. After a Certificate of Incorporation has been issued and duly filed according to the law and after the election of the Board of Directors by the members, the Corporation may commence its non-profit activities with an initial budget of Seven Thousand Eight Hundred Dollars (\$7,800.00) and/or donated equipment and assets as the initial capital. The Corporation shall continue its non-profit mission until dissolved by the proper action of its governing body or in accordance with its bylaws.

## ***ARTICLE V***

The initial Board of Directors shall consist of three (3) members, and their names and addresses are:

The business and affairs of this Corporation shall be managed by its Board of Director(s) except as may be otherwise provided by the laws of the Commonwealth of Kentucky. The number and election of the Board of Director(s) shall be regulated by the members of the Corporation and laws of the Commonwealth of Kentucky.

Each initial Director shall hold office until the first annual meeting of the members of this Corporation and until their successors have been elected and qualified.

The number of Directors thereafter shall be as the Bylaws of the Corporation may, from time to time, provide.

## ***ARTICLE VIII***

The Board of Directors shall not consist of less than three (3) people nor more than nine (9) persons as may be determined from time to time by the by-laws of this Corporation and the laws of the Commonwealth of Kentucky. The Board of Directors of the Corporation shall not be required to be members to qualify for membership on the Board of Directors. The Board of Directors shall be adopted by the members at the first meeting of the legal procedure authorized by the Articles, by-laws of the Corporation, and the laws of the Commonwealth of Kentucky.
