ARTICLE I Name

The name of the corporation is OUTREACH FOR ADDICTION MINISTRY, INC.

ARTICLE II Purposes and Powers

(A) The corporation is organized and operated exclusively for educational and charitable purposes by any means permitted under the laws of the Commonwealth of Kentucky and under Section 501(c)(3) or corresponding future sections of the Internal Revenue Code.

In furtherance of the general purpose in paragraph (A), the particular purpose of the **(B)** corporation is to operate as a Christian ministry focused on helping those suffering from addiction, depression, anxiety and other strongholds to find hope, love, healing and freedom in JESUS.

In carrying out its corporate purposes the corporation shall have the power to buy, (C) sell, lease, or rent any and all items commonly associated with other nonprofit corporations as allowed by law; the power to employ any and all personnel necessary to conduct business as allowed by law; the power to own and acquire by purchase or lease all real estate and buildings necessary to promote and carry on said business as allowed by law; and the power to engage in any and all other activities allowed corporations by the Kentucky Revised Statutes. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on:

by a corporation exempt from federal income tax under Section 501(c)(3)(1)of the Internal Revenue Code, or the corresponding section of any future tax code; or

by a corporation, contributions to which are deductible under Section (2)170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more (D) exempt purposes with the meaning of the section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of as described above, shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such
