Articles of Dissolution

NPD

Pursuant to the provisions of KRS 14A and KRS 273.313, the undersigned corporation executes the following articles of dissolution:

Article I: The name of the non-profit corporation is **FGB9 FEDERAL RESERVE DEPOSITORY, INC.**

Article II: The date the dissolution was authorized: **4/23/2023**

Article III: This dissolution was approved by **the members.**

- (d) Other assets, if any, shall be distributed in accordance with the provisions of the articles of incorporation or the bylaws to the extent that the articles of incorporation or bylaws determine the distributive rights of members, or any class or classes of members, or provide for distribution to others;
