Pursuant to KRS 14A and KRS 275, the undersigned hereby forms a nonprofit limited liability company and for that purpose sets forth the following:

Article I: The name of the nonprofit limited liability company is

Article IV: This entity is managed by **Managers**.

Article V: The purpose of the nonprofit limited liability company is **to nurture the whole child's intellectual, social, and emotional development through a child-centered Montessori education, fostering independent learning, curiosity, and a deep respect for themselves and their environment.**

Article VI: Additional articles not inconsistent with law may be stated in the space below.

Articles of Incorporation

M.A. Montessori Foundation of Glasgow, Inc.

Article I: Name

The name of the corporation is **M.A. Montessori Foundation of Glasgow Inc.**

Article II: Duration

The duration of the corporation shall be **perpetual**.

Article III: Purpose

The purpose of the corporation is **to nurture the whole child's intellectual, social, and emotional development through a child-centered Montessori education, fostering independent**

learning, curiosity, and a deep respect for themselves and their environment; help them to become confident and responsible local as well as global citizens; provide the proper training, services, infrastructure, scholarship opportunities, educational materials needed to do so.

Focus on the whole child: Emphasizes development across intellectual, social, and emotional aspects.

Montessori principles: Use of Montessori methodology to guide learning in all facets.

Independent learning: Fostering self-directed learning abilities through proper instruction, access, educational tools, infrastructure, and environment.

Respect for environment: Infrastructure, educational tools, staff, and lessons that incorporates the importance of environmental awareness and responsibility.

Positive impact on society: Aims to cultivate children who are confident and contribute positively to the world through these principles and creating the proper physical, emotional, social, educational, and spiritual environment for them to do so.

The M.A. Montessori Foundation of Glasgow, Inc. is organized exclusively for charitable, and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of M.A. Montessori Foundation of Glasgow, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

M.A. Montessori Foundation of Glasgow, Inc. is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

Article IV: Registered Agent

The registered agent of the corporation is Mary Ann Alexander, located at 100 Montessori Way, Glasgow, KY 42141

Article V: Incorporators

The names and addresses of the incorporators are as follows:

Article VI: Membership
The corporation shall have no membership.

Article VII: Board of Directors
The affairs of the corporation shall be managed by a Board of Directors consisting of 3 directors. Directors shall be elected in accordance with the bylaws.

Article VIII: Dissolution
Upon the dissolution of the corporation, any assets remaining after the payment of debts shall be distributed to another nonprofit organization that operates for educational purposes and is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code.

Article IX: Limitation on Activities
The corporation shall not engage in any activities prohibited under Section 501(c)(3) of the Internal Revenue Code, including political campaigning or substantial lobbying activities.

Article X: Indemnification
To the fullest extent permitted by law, the corporation shall indemnify its directors and officers against any and all expenses and liabilities incurred in connection with the corporation, provided that such indemnification shall not apply to matters arising from gross negligence or willful misconduct.
