ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF SUMMIT SALES & MARKETING, INC.

Pursuant to the provisions of Section 271B.10-060 of the Kentucky Revised Statutes, the undersigned Company adopts the following Articles of Amendment to its Article of Incorporation:

FIRST: The name of the Company is Summit Sales & Marketing, Inc.

SECOND: The following amendment of the Articles of Incorporation was adopted by the Board of Directors and the shareholders of the Company on January 1, 2021 in the manner prescribed by Section 271B.10-030 of the Kentucky Revised Statutes:

Article V of the Articles of Incorporation is amended to read as follows:

"ARTICLE V. The total number of shares of stock authorized to be issued and the authorized class thereof shall be twenty thousand (20,000) shares of no par value common stock. The voting power of the stock shall be one (1) vote per share. The corporation is formed and its stock is issued as a small business for the purpose of Internal Revenue Code Section 1244."

THIRD: The designation, number of outstanding shares, number of votes entitled to be cast by each voting group entitled to vote separately on the amendment, and number of votes of each voting group indisputably represented at the meeting, were as follows:
