**AMENDED AND RESTATED ARTICLES OF ORGANIZATION  
OF

These **AMENDED AND RESTATED ARTICLES OF ORGANIZATION** shall replace all prior Articles of Organization, specially including the original Articles of Organization dated the 11<sup>th</sup> day of January, 1983.

**ARTICLE I.**

**NAME**

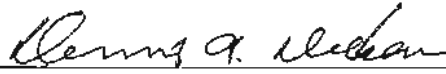

**STATEMENT OF THE REGISTERED AGENT**

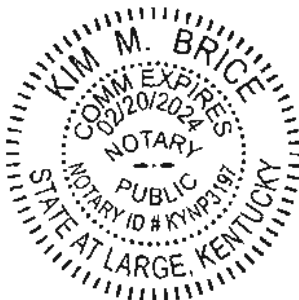

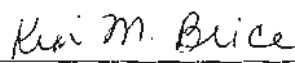
